School Choice Application Procedures
2019 - 2020

The Norton Public Schools will accept applications for a limited number of “seats” for non-resident students exclusively under the State’s School Choice Law. The number of “seats” available are noted below:

Kindergarten – Grade 5	Ten (10) seats each grade
Grades 6 – 10	No cap

1. Applications for School Choice are available on the District’s website at: www.norton.k12.ma.us under the “Families” tab, in person at the Superintendent’s Office, 64 West Main Street, Norton, MA 02766, or by calling (508) 285-0100.
2. Applications for School Choice will be accepted by the Superintendent of Schools via the U.S. Postal Service (postmarked March 25, 2019 or later) or hand carried starting March 25th between the hours of 8:00 a.m. – 4:00 p.m. **NO APPLICATIONS WILL BE ACCEPTED OR PROCESSED PRIOR TO MARCH 25, 2019.**

3. Admission will be determined on a rolling basis until seats are filled. **Admission is closed once seats have been filled or on September 1st of each year, whichever comes first.**
4. All applications will be considered complete once an interview is scheduled with the Superintendent’s Office.
